14. ASHINGTON COMMUNITY WOODS PROJECT

15. MINING WHEEL AT QEII COUNTRY PARK

To receive a proposal from Ward Cllrs to contribute £980 towards the costs of essential maintenance and paintwork to the Mining Wheel at QEII Country Park from their Environmental Enhancement budget heading, sharing the costs across wards, and to agree to confirm the contribution with Northumberland County Council, as the landowner.
