Suggested Venue: Ashington Hirst Welfare (subject to confirmation)

#### Initial Concept

The ECO Fair aims to raise awareness about environmental issues, inspire sustainable action, and showcase local environmental initiatives. Preliminary ideas include:

- Local exhibitors and vendors offering sustainable products and services
- School project displays focused on reducing carbon emissions
- Educational workshops and presentations on various environmental topics
- Interactive demonstrations and activities
- Participation of local environmental organisations
- Local, sustainable food and refreshments
- Children's environmental education activities
- Eco-themed entertainment

These elements are flexible and open to adjustment based on input from Councillors and community stakeholders.

### Next Steps

- 1. Agree those Cllrs who wish to be directly involved.
- 2. Conduct consultations with Councillors and relevant community groups to gather input and refine the concept.
- 3. Hold a planning meeting in the council chamber for all interested parties.
- 4. Establish a communication channel for regular updates and feedback.

## **ECO Fair Concept**

### Purpose

The ECO Fair aims to:

- Raise awareness about environmental issues and sustainable solutions in our local community.
- Inspire and empower individuals and organisations to take action to reduce their environmental impact.
- Provide a platform for local schools and community groups to showcase their environmental initiatives.

### Key Features

Exhibitors and Vendors: An outdoor market (weather permitting) featuring local businesses offering sustainable products and services.

Climate Project Showcase: Displays of school projects focused on strategies to lower personal and household carbon emissions.

Workshops and Presentations: Educational sessions on topics such as renewable energy, composting, zero waste practices, and climate change. This will include repair services and vegetarian cooking classes.

Demonstrations and Activities: Interactive displays and hands-on activities, including a climate change hack-a-thon and wildflower seed distribution.

Environmental Organisations: Local groups will share information about their work and volunteer opportunities.

Local Food and Refreshments: Provided by local farmers and organic food providers.

Kids' Activities: Educational workshops and games for children.

Live Entertainment: Local talent performances and eco-themed art displays.
