We were established as a charity in March 2022 and have a charitable poard with five members sitting on this. We currently have eight teams in arious age categories from 4 year through to 15 years. Our home ground is situated at Newbiggin Sports and Community Hub but use various Ashington based facilities including Dukes Secondary School and Hirst Welfare as training facilities. We currently hae around 100 children participants with a near 50-50 split between Ashington and Newbiggin.

Furthermore our club tries ro support children from families with social and economic problems and give them positive role models and great opportunities to develop themselves in an encouraging and broadening environment.

In addition with our various community links we endeaour to help our families by giving support mechanisms, providing help to minimise children from dropping out, giving advice on broader sporting and leisure pursuits, sign posting on health and welfare problems, and being a central entity for community good.

Another good benefit we bring is the benefit to our local economy through expenditure in local sports venues, expenditure in local sports clothing outlets, expenditure in sports equipment stores, expenditure at local pitch maitenance companies and trophy outlets etc.

Carrying on football can be such an engaging sport cutting across many barriers. At the club we actively encourage breaking down of hurdles which would otherwise compromise opportunities for the children. The barriers we continually face include financial hardship, trying to enhance female participation, trying to provide adapted opportunities for disabled participamts, disinterest in sport from our potential participants and personal issues attributed to psychological problems. We try hard to help in these areas but there is only so much we can do and so any support to aid these areas would be very beneficial.

At the club we also see our club in an important social capacity. We feel our club can help our communities to come together and feel a community spirit. It also is a focus for our local people to have pride in and feel a collective good. This helps in securing special bonds in our communities and aids towards social cohesion. We especially feel this in the support and enthusiasm shared by the local shops and businesses who give us their support in various capacities and share in our collectie successes.

Unfortunately crime in our local areas is another social problem which I feel our club has some elements of ability to help fight against its causes. From this I mean our kids are given an alternative pathway, they are constructively challenged, they benefit from the sporting environment and learn vital skills to be potentially well rounded and positive contributors to our society now and in the future.

Also our teams are represented in a lot of activities which are of good cause. These include community gatherings for charitable causes, armistice day come commemerations, sports community programmes, community school activities and Sports Development opportunities etc. These are golden opportunities for children to learn social responsibility and the opportunities to sculp a better society.

Following on at the club we are trying to ultimately establish an academy like approach whereby children from the development teams at four years old can go through all the various youth age groups and then focus on entering the reserve senior team and hopefully obtain first team status. From this our overall club should go from strength to strength. This future aspiration will see our club featuring in our local area as an an entity contributing to the local economic prosperity.

The club also has it benefits for the local environments that it has helped to enhance. Various pitches in the Ashington and Newbiggin areas have had investment and positive development as a direct result of our club utilising the facilities. Areas like the North Seaton community fields, Hirst Welfare, Dukes Secondary School fields along with Newbiggin Welfare, The Collingwood pitch in Newbiggin and our home ground have all seen positive attributes from staging our junior teams.

Our club has a positive attitude towards learning and development for both the participants and volunteers and officials. We engage with local learning opportunities, we stage learning and training opportunities at our home ground and facilities, we encourage everyone to make the best of the chances given, and hope to evolve with learning partners to bring more enhanced packages of courses to our local pitches and facilities.



Finally our club is there to harness and captivate the young raw talent we have in our local junior football community. We have the ability to make the talent of tomorrow. We love the idea of producing the next local footballing hero like Jackie Milburn or the Charlton brothers. It only takes a few lucky breaks, guidance and motivation by the right people in the right place at the right time. We realish the opportunity to make the dreams come true of our aspiring children but we can only do this with the help of our very appreciated supportive companies/ businesses and organisations.

We as a local amateur club are always working against the pressures of increasing financial burdens. However we can not let this spoil the positive environment we hold so dear for our participants. As such our pitches cost considerably to run and mantain. From the volunteers to the equipment and all the other elements to make these areas places our club can be proud of.

Thus we make this grant application for volunteer training and line paint.

We need to further buy into the development of our home ground by investing in our volunteers and their knowledge of ground / pitch maintenance through the appropriate governing bodies training courses. This would involve undertaking level one and level two courses ran by the Grounds Management Association. Luckily our club is a member of this association and therfore would benefit from some discounts to the aforementioned courses.

The level one course involves undertaking online learning of three modules :

• Requirements of the groundsperson and pitch

- o Pitch and player requirements
- o Introduction to Performance Quality Standards
- o Maintenance activities

• Maintenance activities (Equipment and Machinery)

- o Types of equipment and machinery
- o Equipment and machinery settings
- o Safe use of equipment and machinery

• Safe use and storage (Materials)

- o Storage and safe disposal
- o Types of material
- o Application and effects of incorrect use



These modules will take on average around three hours and the cost for each candidates would be at the reduced rate of £50.

Alternatively the level two course covers the below elements :

The performance requirements of a playing surface;

How to monitor the quality of a surface;

How different maintenance activities might influence

pitch playability;

The responsibilities of operatives and organisations;

The purpose of risk assessments;

Different soil types;

Basic drainage design;

How to identify turf grasses in general;

General control methods for undesirable organisms;

The use of annual work schedules; and

How to create an annual work schedule

These modules would take around six hours and the cost once again would be at a reduced rate of £100 per candidate.

Finally line paint for replenishing lines - red / blue / white all cost around £40 for 10 litre drums.
